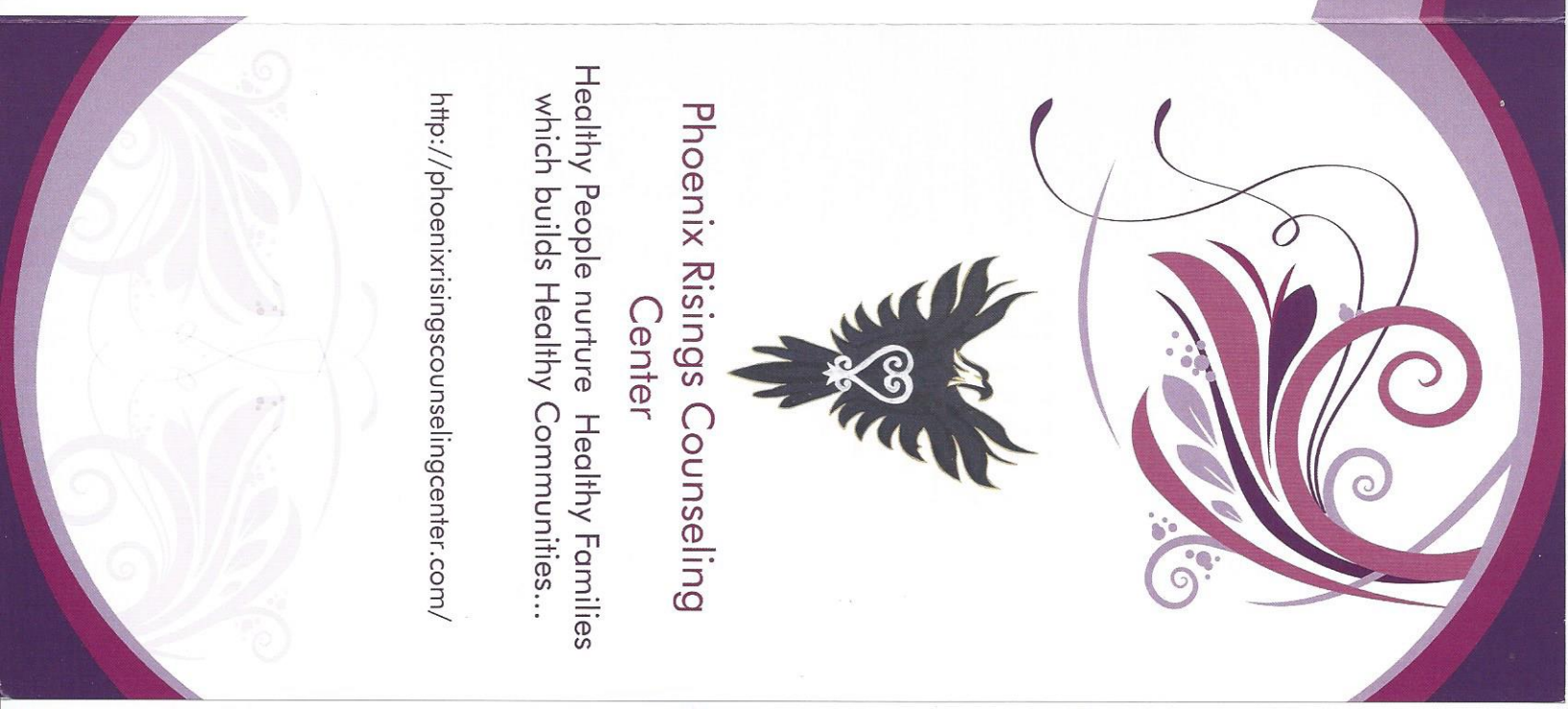

DOT/SAP Evaluations
Phoenix Rising's Counseling Center provides DOT/SAP evaluations for those covered under the Department of Transportation 49 CFR Part 40 rules under the Omnibus Transportation Act of 1991 or its updates. This includes truck drivers and others holding a CDL. Assessments also take into account the different Modal (OA) Rules as well as all updates concerning Return to Duty process. Call 973-393-0312 or 973-646-4690 to schedule your DOT evaluation today. We make every effort to see DOT evaluations within 24-48 hours. The cost for clinical SAP evaluation, including tools, treatment and/or education recommendations, treatment monitoring, follow-up assessment and all compliance reporting is reasonable. The typical length of an initial SAP evaluation is approximately two hours.

Phoenix Rising's Counseling Center is also an approved Medicaid CSOC provider.

1. Intensive In Community (IIC) Services which is provided in the home, community, school. Services include individual and family therapy for the youth and family.
2. Behavioral Assistance (BA) Services to provide support to the youth and family while teaching tools to support attainment of therapeutic goals.
3. Biopsychosocial Strength and Needs Assessments to identify and recommend individualized services needed to address problem areas.
